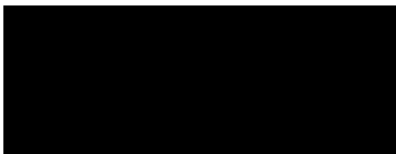

Introduction

Your _____ is a Detective currently employed with the Henderson Police Department (HPD) and a member of the Nevada Internet Crimes Against Children (ICAC) Task Force and Child Exploitation Task Force (CETF). Your Declarant is responsible for investigating a multitude of internet crimes against children and prostitution related crimes to include but not limited to the commercial sexual exploitation of children and sex trafficking.

Your Declarant along with OCE conducted an undercover operation where OCE posed as a 15-year-old juvenile. This is a joint operation with CETF, ICAC and HPD leveraging the internet to identify individuals who have a sexual interest in children. The operation utilizes known chatting and dating websites/applications.

INITIAL CONTACT

On 08/06/2025, an Online Covert Employee (OCE), and a member of the FBI Child Exploitation Task Force (CETF) and or Nevada Internet Crimes Against Children Task Force (NV ICAC), was connected to the internet in an online undercover capacity in Henderson, Clark County, Nevada participating in online activity using a publicly available internet chatting application platform during an undercover operation.

During the operation a software program was used to record the online activity, chats, and media identified within the internet chatting application platform(s) known as "Pure" and later "Whatsapp" with phone number + [REDACTED]. The purpose of the undercover operation was for an OCF to look into an application, in this case the application platform was "Pure" and later "Whatsapp" with phone number [REDACTED], to identify individuals who are involved with the sexual exploitation of children. In general, a mobile application, such as the application listed above, can be downloaded and installed (typically on an Android or iOS device), and allows users to text, chat, talk, or otherwise communicate and share media, in the form of pictures/videos of themselves, to an anonymous or known audience, and/or fellow users of the application.

It should be noted that features pertaining to various application platforms vary and the features of one particular application platform may not include or be the same as the features of another; however similar they may be. Typically, application platform users can post comments, chat, and interact with people (i.e., hold conversations, give instructions, arrange meet-ups, or give commands to other users).

Through OCF's training and experience, due to the nature of on-line applications like "Pure" and later "Whatsapp" with phone number +[REDACTED] subjects are much more likely to encourage a child to produce child sexual abuse material (CSAM), formally referred to as child pornography or to use these platforms to speak to and possibly coordinate a meeting date/time and location for sexual contact with a child.

On or about the dates immediately prior to 08/06/2025, an individual using the platforms "Pure" and later "Whatsapp" with phone number +[REDACTED] was found to have engaged in a conversation with an OCE. That chat conversation turned sexual in nature. During this online undercover communication, it was identified that this user used this platform to talk to an OCE (decoy) acting as a 15-year-old female juvenile and spoke about sexual contact with that minor. The user later agreed to meet the decoy for sexual contact at a predetermined meeting location. The sexual contact included bringing a condom and taking the decoy to "Cirques de Soleil" ["O"].

Prior to meeting, photographs of the subject communicating with the decoy juvenile were obtained. The suspect advised they would be arriving in an Uber.

While the OCE was in contact with the subject and being made aware the subject may be in the area of the predetermined meeting location, task force officers contacted a white male adult located in a silver [REDACTED] that was believed to be the subject in question. The subject was contacted at [REDACTED]. It should be noted that Officer J. Hajar P#2714 contacted the subject, later identified as Tom Alexandrovich (DOB [REDACTED]) while a body worn camera was in operation and recording the contact with Alexandrovich.

Every attempt was made to positively identify the user that agreed to the sexual contact with a minor prior to any contact being made by arresting officers. The subject was identified as Tom Alexandrovich (DOB [REDACTED]) prior to being contacted.

On 08/06/2025 at approximately 1917 hours, after making initial contact with Alexandrovich, Alexandrovich was placed into custody without incident.

During contact with Alexandrovich it was determined that he was in possession of a cellular device.

It should be noted that the OCE attempted to make contact with the device the subject was speaking to the OCE on to verify the device was in fact the one determined to be in Alexandrovich's possession. The device did not alert/sound a notification at that time.

Alexandrovich was advised that he was being placed under arrest and was transported to the Henderson Police Department North Substation Area Command for processing. The located cellular device was seized and also transported to the Area Command, where it was later secured as evidence, pending a search warrant.

Due to the aforementioned facts and circumstances, I determined that based on the undercover communications made using "Pure" and later "Whatsapp" with phone number + [REDACTED] in addition to the fact that Alexandrovich did indeed arrive at the aforementioned location, and that he matched the depiction of the subject in communication with the decoy juvenile based on the images of the subject obtained while engaged in that communication by the decoy juvenile, that Alexandrovich was the same person in contact with the OCE during the aforementioned communication, using a mobile device.

SUSPECT INTERVIEW (COMPLETED BY INTERVIEW TEAM MEMBER):

Upon Alexandrovich's arrival at the Henderson Police Department North Area Command, a recorded interview with Alexandrovich was conducted by [REDACTED]. A brief summary of that interview is as follows:

Tom Alexandrovich:

On August 6, 2025 at approximately 2000 hours, at the Henderson Police Station, located at 225 E. Sunset Road, Henderson, Nevada 89011. Homeland Security Investigator [REDACTED] FBI Special Agent [REDACTED] conducted a post-

arrest interview of Tom Alexandrovich. [REDACTED] used an audio recorder to record the interview, and closed-circuit video cameras simultaneously made an audio/visual recording of the interview. The duration of the interview was approximately thirty-one (31) minutes in length. The following is a summary of Tom Alexandrovich's statements:

The interview commenced at 2000 Hours

Alexandrovich's DOB: [REDACTED]. Native language Russian, is Hebrew; agreed to speak and fully understands English. Walch advised Alexandrovich of his Miranda rights at approximately 2007 hours, which he waived. Walch advised Alexandrovich due to being from Israel, the Israeli consulate could be notified, Alexandrovich agreed at 2020 hours.

Alexandrovich is from Israel and is visiting for the Blackhat conference, works for the Israeli government agency and has so for approximately fourteen years.

Alexandrovich stated he has never been arrested and was not familiar with the consequences of speaking or not speaking with US authorities.

[Agent note: Walch stated he was not able to give legal advice, however if Alexandrovich wanted his story to be heard he was able to speak to Investigators.]

Alexandrovich stated he has a meeting with the NSA tomorrow and had met several Bureau people and NSA people over the past week.

Alexandrovich described the Bureau Agents as one white guy who was tall and bald and one black guy.

Alexandrovich stated he was at the conference to learn.

Alexandrovich stated he was in the United States approximately three months ago for a cryptocurrency conference in New York City.

Alexandrovich stated he comes to the United States approximately two-three times a year.

Alexandrovich stated he uses an international phone number to chat.

Alexandrovich stated he could not remember the name of the girl he was chatting with, but he had met her on the Pure Application.

Alexandrovich stated he had photos of himself on Pure and could not recall if he sent photos via the application.

Alexandrovich stated he is currently staying at the Conrad Hotel on floor 53.

Alexandrovich stated he uses the name "Adam" to chat on dating applications.

Alexandrovich stated he agreed to go to dinner and a show with a date.

Alexandrovich stated he believed the girl was 18 years old, that was the age listed on the Pure application.

Alexandrovich stated he felt the girl "pushed" him to talk about bringing a condom yet could not remember how many times the girl "pushed" him.

Alexandrovich stated he was embarrassed for being arrested.

Alexandrovich questioned how much bail would cost and why was he under arrest.

[Agent note: Walch advised Alexandrovich he would be transported to jail while under arrest, due to the chats with being with a girl of the age of fifteen and their communication of sex and a condom.]

Alexandrovich stated he would need his glasses as his contacts were in his eyes.

Alexandrovich stated he had his family members phone numbers memorized.

Alexandrovich stated he was in shock and he needed to contact someone about his international flight back to Israel.

Alexandrovich stated he did not know the numbers for the Israeli government.

Alexandrovich stated his family was in Israel.

Alexandrovich stated it was very important he get numbers for his flight.

Alexandrovich stated his flight is on Friday to New York and then will fly to Israel.

Alexandrovich stated his phone does not have a password but uses his right thumbprint.

Alexandrovich stated he needed the following numbers from his phone:

Alexandrovich asked if he could message his family or make a call to the embassy; Walch stated that would not be possible now.

Alexandrovich stated he would like to participate in a polygraph.

The interview concluded at 2031 hours.

PROBABLE CAUSE STATEMENT:

Due to the aforementioned facts and circumstances, I determined that based on the undercover communications made using "Pure" and later "Whatsapp" with phone number + [REDACTED] 2, in addition to the fact that Alexandrovich did indeed arrive at the aforementioned location, and that he matched the depiction of the subject in communication with the decoy juvenile based on the images of the subject obtained while engaged in that communication by the decoy juvenile, that Alexandrovich was the same person in contact with the OCE during the aforementioned communication, using a mobile device.

Alexandrovich also admitted to having been engaged in the aforementioned communications with the decoy juvenile as articulated under the summary of his interview.

Due to the aforementioned facts and circumstances, I have determined that Alexandrovich did commit the offense of Luring a Minor Using Technology, a violation of NRS 201.560.4a (Felony).

Alexandrovich was subsequently transported to the Henderson Detention Center and booked accordingly.

Wherefore, Declarant prays that a finding be made by a magistrate that probable cause exists to hold said person for preliminary hearing (if charges are a felony or gross misdemeanor) or for trial (if charges are a misdemeanor).
