Additional Info: I am being severely harassed and have my phones hacked all the time , there are worms on my e-mails. I am being gang stalked. I would like to apply for the documents to be opened. he tried to bribe me with rude photos he had. I told him to publish. He said I was the nicest person he knew and he and Andrew have dragged me through hell and back.. I am a decent woman. i have always worked and I have a degree. I used to read the lessons in church. I have been very private in my life. They tore me and hurt the very soul of me. i need your team to help me end these sex trafficking rings, drain the swamp. I want to sleep at night. Epstein called me electronically on the 6th July 2019. He was [REDACTED] and had come for [REDACTED] I did not know it was him as his voice seemed different. He would not tell me who it was knowing I would hit the roof, as I am not a pedophile and I had told him to get treatment and contact the police. He offered me for the second time his fortune, which \I thought was odd, i think he threatened me. I told him to go as i guessed he was near. He said if I changed my mind to call him and he would give me the money. He knew the police were waiting for him at the airport. He was sad and almost beaten. He came to say goodbye, i thought you might like to know. Please help this nightmare of [REDACTED] years end i have been aware of these things since 2017 but unable to prosecute.

How is Contact Known: The subject tried to traffic me to the states in 1996.

He became a controller and sexually abused me. He was friends with Andrew the Duke of York who did the same thing. There are many others who did the same, I am tired of the fear. I was approached by MI5 to carry a phone to access a conversation between Epstein and I. I believe either Primark or Galen Weston jr touted the information around. Andrew had contacts in ISIS who would be used in France and the UK to carry out terrorist targeting
