[REDACTED], date of birth (DOB) [REDACTED], cellular telephone number [REDACTED], was interviewed telephonically. After being advised of the identity of the interviewing Agent and the nature of the interview, [REDACTED] provided the following information:

[REDACTED] contacted BOIES SCHILLER and talked with SIGRID MCCAWLEY, who referred her to the FBI. In the early 1990's, [REDACTED] worked for CHARLES DE JOURDAN, and the company flagship was in TRUMP TOWER.

[REDACTED] was in her early twenties when she would go to school at night while working full time. During her lunch hour, she would study in public places in TRUMP TOWER because she worked in a building nearby. At the time, [REDACTED] recalled that there were TOWER RECORDS downstairs near the escalators and there was a waterfall. There were 25-30 tables in the public area. [REDACTED] met a colleague and he pointed out two men in their early thirties. [REDACTED] described one of the men was dark haired and looked like ANTONIO BANDERAS while the other man was blonde and looked like the surfer type. Her colleague told her that the men constantly picked up [REDACTED] women.

[REDACTED] was approached by the dark haired man who asked her if she was a student and what she was studying. She told him her name and where she worked. He asked her if she knew who DONALD TRUMP was and told her he was meeting people that day. At this point in time, TRUMP has been in the tabloids in reference to his divorce from his first wife. [REDACTED] told the man that she knew who TRUMP was. The man asked her if she wanted to meet TRUMP and told her that she did not need to work so hard to go to school. The man winked and said he could do whatever she liked.

[REDACTED] felt that it was clear that sex was on the table even though the man never mentioned sex. [REDACTED] felt these men were playing the role of recruiters for TRUMP. The man told her that if she did not want to meet TRUMP right then she could go to a party. The man told her that she could

bring a friend if the friend looked like her, but she could not bring a guy. The invitation was in or around 1990/1991 and the invitation had JEFFREY EPSTEIN's address on it. [REDACTED] knew the residence was next to a museum. [REDACTED] had a friend, [REDACTED] who lived near the mansion, so she recognized the address. [REDACTED] did not go to the party.

[REDACTED] said that she received death threats when she did not want to go meet TRUMP. The threats consisted of the men saying that they knew where she worked and could find her. [REDACTED] never told the police because she did not think they would believe her. The men did not talk to her after that. [REDACTED] told her mother and boyfriend. [REDACTED] saw the men approach females for approximately five to six months. [REDACTED] thought most of the females approached were tourists - there were a lot of tourists in and around TRUMP TOWER. [REDACTED] saw girls, usually blondes, approximately 15/16 years old with one of the two men and saw them get on an escalator. [REDACTED] never saw any females meet with TRUMP.

Later in the 1990's, [REDACTED] was working in cosmetics and there was an event in TRUMP TOWER. TRUMP showed up with bodyguards and [REDACTED] women around 22/23 years old.

[REDACTED] had been in touch with the press since 2015. [REDACTED] [REDACTED] recalled seeing a video on HOWARD STERN with TRUMP and IVANKA TRUMP. [REDACTED] also saw 60 MINUTES with STORMY DANIELS. [REDACTED] knew EPSTEIN and TRUMP both had home in New York and Palm Beach. WITNERFIELD stated EPSTEIN and TRUMP stopped talking because of their financial means and they both stole money from people. When asked how she knew this, [REDACTED] stated it was common knowledge. [REDACTED] had seen documentaries about EPSTEIN where she saw [REDACTED]. This was how she learned of BOIES SCHILLER.

[REDACTED] knew a woman named [REDACTED] who worked for CALVIN KLEIN cosmetics and knew that her daughter, who was a tall blonde, went to [REDACTED]. [REDACTED] recalled the daughter was waiting for her mother and went upstairs to meet TRUMP. This was in the early 1990's.

[REDACTED] recalled sometime later seeing [REDACTED] at a cocktail party and the woman said something horrible happened to her daughter that day. The daughter had dropped out of school, got into drugs, and committed suicide.

[REDACTED] later found [REDACTED] through LinkedIn and called her. [REDACTED] told

her that her life was ruined and not to call her again.

[REDACTED] called [REDACTED], who worked for TRUMP. [REDACTED] told [REDACTED] that TRUMP would be in the office at 7AM after partying all night. [REDACTED] told [REDACTED] that TRUMP did cocaine in the 1980's.

[REDACTED] spoke with ELLIOT SPITZER and he told her to contact the Attorney General ERIC SCHNEIDERMAN. [REDACTED] did not speak to SCHNEIDERMAN; both had scandals. SPITZER told her she needed to contact the FBI before TRUMP was elected. [REDACTED] contacted the FBI in or around 2006 and was put on hold to speak to an agent but was not transferred.

In or around 2016, [REDACTED] met MELANIA TRUMP and BARRON TRUMP. [REDACTED] was tutoring Spanish to another student, who was 11/12 years old. The student's [REDACTED] knew MELANIA and "dished" about MELANIA's marriage to TRUMP, saying that it was a "battered" marriage.
