JUAN ALESSI, cell phone number [REDACTED] was interviewed at [REDACTED] [REDACTED]. Present for the interview was AUSA [REDACTED] [REDACTED]. After being advised of the identities of the above listed individuals and the nature of the interview, ALESSI provided the following information:

Before ALESSI and his wife left JEFFREY EPSTEIN's employment, they only saw two young girls, [REDACTED] [REDACTED] and [REDACTED] [REDACTED]. There were a couple times ALESSI picked them up from school.

[REDACTED] recently spontaneously visited ALESSI and his wife the prior week at their home so [REDACTED] could clarify things. [REDACTED] had a female reporter with her. ALESSI thought they were doing a book and trying to help victims. ALESSI thought he recalled [REDACTED] asking if he remembered her being at EPSTEIN's home. ALESSI told [REDACTED] he did recall her being there. ALESSI knew that [REDACTED] was young because he recalled picking her up from school. [REDACTED] and the reporter wanted to do a video with ALESSI and he told them no. Many reporters have contacted ALESSI and offered him money, including Australia's "60 Minutes". ALESSI did not want to talk to any of them.

ALESSI met [REDACTED] at EPSTEIN's home in Palm Beach. The first time [REDACTED] was at EPSTEIN's home, she came with her mother ([REDACTED] [REDACTED]). As far as ALESSI knew, [REDACTED] was not a massage therapist. [REDACTED] and her mother went to EPSTEIN's house a couple of times. [REDACTED] mother was very interested in meeting EPSTEIN. ALESSI felt that [REDACTED] mother sold [REDACTED] to EPSTEIN. ALESSI described [REDACTED] mother as [REDACTED] [REDACTED]. ALESSI knew [REDACTED] was young because he had picked her up from school; [REDACTED].

█████ went alone to EPSTEIN's home; sometimes ALESSI picked her up. ALESSI picked █████ up from her home █████. EPSTEIN told ALESSI to pick up █████ and bring her to his house. After ALESSI would walk in the house, █████ would be with EPSTEIN and GHISLAINE MAXWELL. █████ went to the movies with EPSTEIN and MAXWELL late at night. ALESSI never saw █████ go upstairs behind locked doors, nor did he see her do "anything bad". ALESSI was not allowed in conversations between █████, EPSTEIN, and MAXWELL. ALESSI stayed away from them, usually in the kitchen, while they were in another room. █████ gave massages; that is what she was hired to do. To the best of ALESSI's knowledge, █████ did not give massages. EPSTEIN closed doors and shutters. After they all had gone to the movies, █████ may have gone upstairs; ALESSI was not there that late. ALESSI was the one who always picked others up; his wife did not as she was responsible for running errands and also booked movie tickets.

ALESSI knew that █████ was █████. █████ was a very pretty girl. EPSTEIN told █████ that he was helping █████ █████. One time, █████ told ALESSI that EPSTEIN was helping her. Most of the time, MAXWELL told him to pick up █████. Most of the orders came from MAXWELL. ALESSI could not remember if he took █████ to the airport. When guests arrived to the airport from international flights, ALESSI would drive girls and PRINCE ANDREW. When going to the airport, ALESSI went first with the luggage while EPSTEIN, MAXWELL, and others went in a different car. ALESSI could not remember if █████ flew with EPSTEIN but thought it was possible. ALESSI said the flight logs should show if █████ was on EPSTEIN's plane.

From EPSTEIN and MAXWELL's office, MAXWELL would tell ALESSI to buy movie tickets and come back with them. ALESSI recalled a movie theater in Boca Raton that was high class with couches that they frequented called something like "Boynton Beach Cinema". If EPSTEIN was in town, he went to the theater almost every night. They went to the movies approximately three times a week. ALESSI or his wife would pick up the tickets. There was also another theater in West Palm Beach they frequented. When █████ went to the movies with them, it was usually around 9pm/10pm. A lot of men and women, some EPSTEIN's friends and some MAXWELL's friends also went, including █████ █████. There were so many girls, not young girls though. EPSTEIN never went alone with MAXWELL; there were always others around.

EPSTEIN always traveled with people. [REDACTED] was not there all the time but if she was, she would go with EPSTEIN, MAXWELL, and [REDACTED]. Usually it was EPSTEIN, MAXWELL, and [REDACTED] but ALESSI thought maybe others went as well.

ALESSI never heard [REDACTED]

ALESSI did not see [REDACTED] naked or topless. ALESSI picked [REDACTED] up at her school and at home. ALESSI never paid [REDACTED] or [REDACTED] money. ALESSI paid massage therapists \$100 and had receipts that he would send to EPSTEIN's office. ALESSI did not think that he had ever called [REDACTED]. ALESSI drove three black Mercedes while employed by EPSTEIN. When ALESSI would pick [REDACTED] up, she knew that he was picking her up. MAXWELL would tell ALESSI to pick her up, but he did not hear the conversations between MAXWELL and [REDACTED]. The first time that [REDACTED] and her mother came to the house, her mother drove them. [REDACTED] was too young to drive. When ALESSI picked [REDACTED] up, she would always sit in the back. The house rules were that no one could sit next to ALESSI in the car; he was told this by EPSTEIN and MAXWELL. ALESSI was never supposed to start conversations, never ask questions, and not to talk to the other staff. In the end of working with EPSTEIN, ALESSI was not allowed to look EPSTEIN in the eyes. ALESSI hated it and left EPSTEIN's employment because they wanted him to leave.

ALESSI recalled that EVA ANDERSSON was wonderful to him. ANDERSSON was very pleasant. ALESSI recalled ANDERSSON being there for around five months, then MAXWELL came into the picture. When MAXWELL came in, everything changed. ANDERSSON married and ALESSI thought [REDACTED] [REDACTED]. EPSTEIN and ANDERSSON remained friends and ANDERSSON still visited EPSTEIN. EPSTEIN was pleasant before MAXWELL was around. EPSTEIN used to talk soccer with ALESSI, [REDACTED] [REDACTED]. When MAXWELL arrived, the younger girls came into the picture. When MAXWELL arrived, "everything went to hell". ALESSI thought that ANDERSSON and MAXWELL had a friendship but were not close. ALESSI thought they may have hated each other.

ALESSI was asked if he recalled someone named [REDACTED] and replied that he

did not remember. ALESSI recalled meeting many British individuals, including [REDACTED] and RUBY, whose last name he could not remember. RUBY was around all the time and was friends with MAXWELL and EPSTEIN.

ALESSI recalled seeing a black costume in MAXWELL's closet along with all kinds of toys in a basket. ALESSI did not see other costumes or people in them.

[REDACTED] mother brought food to the house. ALESSI recalled [REDACTED] mother tell EPSTEIN something like, "Whatever you want to do with [REDACTED], she can come anytime".

ALESSI did not see girls naked in the house. ALESSI recalled when an English girl came into the kitchen topless, he told her to get a towel and then come back in.

ALESSI recalled seeing many different people at EPSTEIN's home, including senators, PRINCE ANDREW, DONALD TRUMP, ROBERT KENNEDY, mathematicians, and many others.

ALESSI witnessed EPSTEIN kissing girls on the cheek and patting them on the buttocks. ALESSI saw EPSTEIN do this to [REDACTED].

[REDACTED] mother had a car; he did not pick [REDACTED] mother up. ALESSI could not recall if he picked [REDACTED] up from the ballet.

ALESSI was relieved that EPSTEIN had died, saying EPSTEIN was a dangerous man.
