My name is [REDACTED]. Ghislaine is my older sister. The man in the photographs from the Navajo Nation was the code keeper got the vault accessable only by a general on an island in Akhail Beach India. He has the keys to all the rooms of Epstein's video tapes.

I filed a sexual Harrasement suit against him as a contractor for the FBI and a volunteer for Global Canada Mounties in conjunction with the mission unknown soldier where I was left to complete an investigation with the accounting department.
